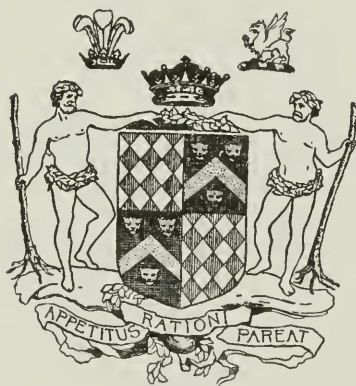

## ROAD AGENT'S REPORT

---

### MAINTENANCE AND NEW CONSTRUCTION

The highway department has performed the usual maintenance work on town roads in the past year. This has included grader work and the trucking and placing of gravel in many places. The roadsides were all mowed once, and the usual winter plowing and sanding was done.

Twenty-one new culverts were installed, either to replace old ones or in new places.

The total amount of gravel hauled and put on town roads was 6,043 cubic yards.

The following new construction was carried out:

1. One street in the depot village was widened, rebuilt and oiled.
2. Two new pieces of road were built at the south end of Laurel lake, one to extend the black top to the Cox-Bullock place on the old road to Royalston, and the other to extend the black top from the Fleur de Lis Camp to the west for a considerable distance.
3. The road by the Spicer residence at Bull Run was gravelled.
4. Some of the road in the old cemetery was graded and newly gravelled.

### OILING TOWN ROADS

This year 2.3 miles of black top road was surface treated with stone, grits and asphalt top, and also 2.2 miles was treated with asphalt sealing.

In addition to this about 80 cubic yards of patching mix was used in repairing wear on existing black top roads.

Submitted herewith is the report of the annual audit and examination of the accounts of the Town of Fitzwilliam for the fiscal year ended December 31, 1951, which was made by this Division in accordance with the vote of the Town. Exhibits as hereafter listed are included as part of the report.

**SCOPE OF AUDIT**

Included in the audit and examination were the accounts and records of the Board of Selectmen, Treasurer, Tax Collector, Town Clerk, Road Agent, Trustees of Trust Funds, Plante Memorial Park Commission, Treasurer of the Elliot Institute, Library Treasurer and Village District.

**FINANCIAL STATEMENTS**

Comparative Balance Sheets—Dec. 31, 1950—Dec. 31, 1951: (Exhibit A)

Comparative Balance Sheets as of December 31, 1950 and December 31, 1951, are presented in Exhibit A. As indicated therein the financial condition of the Town changed from a Surplus of \$1,198.57, to a Net Debt of \$1,102.67, during the year 1951.

Analysis of Change in Financial Condition: (Exhibit B)

An analysis of the change in financial condition of the Town during the year is made in Exhibit B, with the factors which caused the change indicated therein. These were as follows:

## Comparative Statements of Appropriations and Expenditures—Estimated and Actual Revenues: (Exhibits C &amp; D)

Comparative statements of appropriations and expenditures, estimated and actual revenues for the fiscal year ended December 31, 1951, are presented in Exhibits C and D. As indicated by the budget summary (Exhibit D), a net unexpended balance of appropriations of \$893.62, less a net revenue deficit of \$217.94, resulted in a net budget surplus of \$675.68.

## Summary of Receipts and Expenditures: (Exhibit E)

A summary of receipts and expenditures for the fiscal year ended December 31, 1951, made up in accordance with the uniform classification of accounts, is included in Exhibit E. Proof of the Treasurer's balance as of December 31, 1951, is indicated in Exhibit F.

## AUDIT PROCEDURE

The accounts and records of all town officials charged with the custody, receipt and disbursement of public funds were examined and audited. Vouchers and cancelled checks were compared with supporting invoices and payrolls as well as entries in the books of record. Receipts were checked by source insofar as possible and totals of receipts and expenditures verified. Book balances were verified by comparison with reconciled bank balances made from statements obtained from depository banks.

## GENERAL COMMENTS

### Conclusion:

The accounts and records of all town officials which we examined were found in good condition and the accounting procedure conformed to the prescribed methods.

The provisions of Section 31, Chapter 211, of the Laws of 1939, require that this report or a summary of its essential features shall be published in the next annual town report.

We extend our thanks to the officials of the Town of Fitzwilliam for their assistance during the course of the audit.

To the inhabitants of the School District in the town of Fitzwilliam qualified to vote in district affairs:

You are hereby notified to meet at the Town Hall in said district on the 5th day of March 1952, at 2:00 o'clock in the afternoon, to act upon the following subjects:

Art. 1. To bring in your votes for the election of a moderator, clerk, board member and treasurer.

The polls will be open not later than 2:00 p. m. and close not earlier than 9:00 p. m.

You are hereby further notified to meet at 7:30 o'clock in the evening of March 5th, 1952, at the town hall to act upon the following subjects:

Art. 2. To hear and act upon the reports of agents, auditors, committees or other officers chosen.

Art. 3. To see if the district will vote to petition the State Tax Commission to have an audit of the school accounts by the division of municipal accounting, or take any action thereto.

Art. 4. To see what sum of money the district will raise and appropriate for the support of schools, for salaries of school district officers, auditors and agents, and for the payment of statutory obligations of the district, and to authorize the application against said appropriation of any sums as are estimated to be received from the state equalization fund together with other income; the school board to certify to the selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the town, or take any action thereto.

Art. 5. To see if the district will vote to raise and appropriate the sum of two thousand two hundred forty-four and nineteen one-hundredths dollars (\$2,244.19), to be made available to the school district prior to July 1st, 1952 in order to reimburse the 1950-51 budget deficit as referred to in this report, or take any action thereto.

Art. 6. To see if the district will vote to raise and appropriate \$250 for the purpose of a suitable plaque on the school building and appoint a committee to purchase same and arrange for a dedication ceremony, or take any action thereto.

Art. 7. To see if the district wishes to transport the pupils from the village common and the depot, to and from the school and raise and appropriate \$90 for the additional cost for one year, 1952-53 or take any action thereto.

Art. 8. To see if the district wishes to transport pupils living in districts subject to bus routes, to and from a specified distance other than the one and one half miles to a bus line, as provided in Chap. 135, Sec. 8 of the revised laws, and authorize the district to raise and appropriate the additional sum of \$270 to cover the cost for one year 1952-53, or take any action thereto.

Art. 9. To see if the district will vote to raise and appropriate the sum of \$970.59 to be made available to the school district prior to July 1st, 1952 in order to meet the additional expense of the new driven well, which amount is above the balance of the well account \$1,492.08, or take any action thereto.

Art. 10. To see if the citizens of the Fitzwilliam School District will vote to continue the study of a cooperative district, the purpose being for the study group to recommend changes in the present Enabling Act, the object of said changes to make it possible to bring more acceptable plan to the towns interested.

Art. 13. Voted to accept as written \$4,200 to meet obligations of capital outlay and interest on bonded indebtedness.

Art. 14. Voted to postpone indefinitely cooperative school study.

Art. 15. No business. Motion by Mr. West polls be closed. So voted. Polls closed at 9:55 p. m.

## REPORT OF SUPERINTENDENT OF SCHOOLS

---

The new school year opened on Sept. 5, 1951 with the return to their teaching positions of all members of the staff except Mr. Pratt, who accepted a position as school principal in Orleans, France. It is a distinct advantage to the children of the school to have the services of experienced and well-trained teachers who are acquainted with the community over a number of years, as is the present staff.

The success of the school program rests upon teachers who are well supplied with the tools of their trade,—books and equipment. As superintendent, I feel that my most important job is to encourage and help the teachers and to provide them with the best tools available for their work. To that end, each teacher has been visited in her classroom once every two weeks. In this way, the resources of the film strip library, picture file and phonograph record library at the union school office, is readily available.

In my opinion, it is regretable that Fitzwilliam, with its fine lunchroom and kitchen, did not participate in the Federal Lunch Program. This program is operated at no cost to the local community through the United States Agricultural Department. So far this year many foods such as apples, prunes, peanut butter, peaches, peas, beans, orange-juice, cheese and others have been distributed. Fitzwilliam's share of these foods was valued at over \$500. Fitzwilliam was the only community in the state to drop out of the Federal program.

Efforts should be made to grade and seed the school grounds this year. The problem of protecting the floors from mud and sand is a difficult one for the janitor.

The PTA deserves real praise for its work in providing playground equipment, library books and support for the school program. May their efforts continue.

#### REPORT OF STAFF

Mr. Charles L. Bowlby, Superintendent of Schools,  
Marlboro, New Hampshire.

We hereby submit our report as staff of Dr. George S. Emerson school.

In Grade One we are busy learning the Three R's. We have new alphabet and phonic cards which are helping us greatly. We are learning to use and enjoy our school library. We are very appreciative of our new playground equipment and enjoy our lovely classroom with its many facilities. We have excellent textbooks and visual aids available to us. We enjoy being in the same building with our brothers and sisters, and thank all who help make our school such a nice place.

The Reading Program is the most important phase of the Second Grade, the other two R's and related subjects each having a place of importance. The Phonetic Method receives the greatest emphasis. Two important factors in enriching reading recently have been colored film strips and the school library. The social life of the children has benefited greatly from our Central School. The children are placed in a more life-like situation, as they associate with children of other ages and interests. This helps to create the favorable attitudes of helpfulness and tolerance. We share daily books, phonograph records, the film projector, the Ditto machine, professional ideas and illustrative materials of marked educational value. The teaching possibilities are, therefore, enriched and subject matter continuity greatly improved.

Although the stress has been on the Three R's in Grade Three, other activities, such as folk dancing and listening to good records, are being enjoyed. Phrase cards,

phonetic drill and film strip are being used in the reading program, and children are being grouped according to their ability. The new school library stimulates interest in reading. Many new devices have been added to make arithmetic more meaningful. Through providing an opportunity for pupils and teachers to work together as a unit, the central school has improved teacher-pupil relationships.

Working together means planning and cooperating ahead of time, solving problems before they become critical, and discussing each other's teaching methods. Working together has meant doing away with a great many problems. We have the advantage of more visual aid equipment, a growing library, and a working Parent-Teacher Association. This has brought about a closer parent-teacher relationship. Because of the fact that after Grade Four arithmetic will become increasingly more difficult, the deep stress has been teaching the pupils how to reason. Reasoning is an inborn trait, but must be nurtured continuously. This means slightly slower progress in subject matter, but greater ultimate results. Where the Social Studies are concerned, the method has been to make the subject matter as life like as all sorts of visual aids will permit. Education is the gaining of usable knowledge in preparation for life. A good preparation makes for a better life.

In the Fifth and Sixth Grades there is emphasis upon teaching the whole child. He must know facts: for example, mathematics needed for life experiences, how to use these facts and where to find what he does not know. He learns to go along and to work happily and successfully with others. Attention is paid to posture, sitting or standing, and other health factors. He also makes repeated decisions, choices and votes for what he considers right. These grades are definitely alive with enthusiasm for nature. Look in on us anytime and see for yourselves. In Domestic Arts, the Junior High Girls are learning good grooming, cooking and sewing, with emphasis upon planning, economizing and care of clothing, furnishings and



foods. We are very grateful to the P. T. A. for the repair of both of our sewing machines.

Our pupils in Junior High school are normal young Americans. Their curriculum consists of more, and advanced, subject matter for mental training and preparation for high school. Self-reliance and critical thinking are encouraged. The ability and desire for self-direction becomes important. An effective form of student council will very soon be instituted. The pupils will grow in knowledge and responsibility for directing their own school affairs, with guidance. Our pupils are fortunate in having woodworking and homemaking with trained teachers. Not all schools offer these courses. Most of the activities mentioned are directly traceable to our central school plant. Our facilities are excellent and we are improving them constantly. We urge all parents to visit us in class.

### STAFF

We are to be envied for the quality of our staff members. Miss Knapton has a wealth of patience and understanding, and a genuine affection for little people, besides being a teacher of great ability. She possesses the characteristics which make the superior first grade teacher. Mrs. Basto, highly competent in other aspects of second grade teaching, is especially apt in communicating a love for art to her pupils. In the third grade room many things are seen, but here is arithmetic at its best, and Mrs. Damon's excellent instruction. Social Studies (geography and history) is Miss Tucker's especial affinity, and her pupils have a lot of "something extra" in that respect, though no studies are slighted. Mrs. Rawding's room is always a beehive of activity, and here are the observable results of cooperative enterprise at its best. Our teachers are good because they like their work. They are better than good because they are in constant attendance at professional training courses, ever-improving and well informed beyond the requirements of duty.

### CURRICULUM

The members of the staff have mentioned in the preceding report the effect of the central school on the curriculum. This is undoubtedly true. The continuity of learning is a highly desirable factor in education, and it has improved in the central school. The teachers are in close touch with the teachers in the next lower and the next higher grades, and pupils benefit because of this. The eight grades mingle in the lunchroom and on the playground, and mature more smoothly. General assemblies are possible. The pupils take care of their new building and show pride in it. A common school spirit now exists. The harvests we reap from our new building are

prodigious. The teaching materials, the textbooks, and methods are up-to-date, for we are educating today's children.

### SPECIAL STAFF

Our Music Supervisor is Mrs. Azalea Wilson, who is well qualified and competent. How the smaller people enjoy her folk dancing periods! Mr. Cecil Nash is our Manual Training instructor, and a very good one. We are fortunate to be able to have his services. Our janitor, or custodian, Mr. Height, keeps the building well. He is efficient and cooperative, always willing to help. Mrs. Height often helps him, and they get along fine with the pupils. The dry food of learning would prove a stale diet to us all if it were not seasoned with the tasty and wholesome meals served by Mrs. Lillbach and Mrs. Baldwin. Our Hot Lunch program runs very smoothly. The School Bus drivers, Mrs. Matson, Miss Flagg, and Mr. Whipple, are reliable and punctual. It is good to feel that the pupils are safely transported, and that a big job is well done. Miss Davis is on hand each morning for sick call and has tested the pupils' hearing. She is a source of comfort to the staff and pupils.

### SCHOOL PLANT

The school plant has proven highly satisfactory. Upon first seeing it, I was struck by the beauty of the natural lighting. The light is evenly distributed in all rooms. Light meter readings of the classrooms prove that they are extremely well illuminated. The artificial lighting is very good. The hot water heating system is steady and comfortable. The teachers' room is well used and fully appreciated by the staff. The playground equipment is an excellent shock absorber of youthful energy, fully appreciated by children and teachers.

### TOWN

The Parent Teacher Association is very active and interested, and to it goes most of the credit for our school library. Enthusiastic might better describe the P. T. A. Many of the citizens have been very helpful in their willingness to lend material to the school. Not only that, but

gifts to the school were a piano and a studio couch. This denotes a fine spirit in the town. The public library has been most considerate and generous toward the school, and has made possible a wider distribution of books to the children through the school library. A Christmas dinner was made possible by generous donations of townspeople. There could hardly be better relations between the people and their school.

In closing, I should like to make three statements. The first is an urgent recommendation that the people of Fitzwilliam consider the landscaping of their school. There is room for much improvement, which need not be expensive. We can all operate a shovel. The second is that, while we have an excellent school plant and staff, a school is never complete without the active, interested support of the townspeople. The survival of any town depends upon its children. The last observation is that I personally find my work in Fitzwilliam very satisfying, and desire to remain and become part of the town.

#### REPORT OF INDUSTRIAL ARTS INSTRUCTOR

Although the shop program is in its embryonic stage, progress is being made toward the essential characteristics necessary as outlined for industrial arts in general education.

It is hoped eventually, that the shop program can be set up as a "general shop," having two or three different activities being carried on at one time. It is within the realm of possibility that this can be accomplished. In order to do this, however, it will necessitate obtaining more power tools of a nature to speed up the time now being spent in getting lumber down to rough dimension and the like. This does not mean that the essential hand tool processes will be excluded. One is as essential as the other. It does mean that a lot more can be accomplished in the precious time allotted to the shop program.

A lot of credit is due last year's classes for the progress shown in the shop. Most of their available time was spent in making benches, etc. It was possible for the instructor to lend a hand after classes, Saturdays and at other times, to do some of the necessary improvements. This year all the time in class has been spent in making projects under guidance. Owing to the instructor's time schedule as set up, it is impossible to spend outside time in the improvement of the shop. However, it is hoped that as time goes on, improvements can be steadily forthcoming, even though the progress maybe slower than anticipated.

# STATEMENT OF SCHOOL LUNCH PROGRAM ACCOUNT

Fiscal Year Ended June 30, 1951

A new kitchen, the addition of running hot water, a Garland gas range and a near by large storage closet made the preparation of lunches a pleasure with a minimum of effort.

The lunchroom accommodates all the children in two sittings, the older ones first, then the little folks, because of their need for more time at the dinner table.

The first four grades made table decorations, while the other grades made wall posters showing the correlation of school lunches and the class room studies. The table decorations were exhibited at the school lunch workshop in Plymouth, which I attended, and also at the School Food Service Association meeting held at the Statler Hotel in New York City.

"Tasters" were delegated daily from the first and second grades, who after a visit to the kitchen to taste the days menu would discuss in their respective classroom the food being served. In this way many new foods were introduced without the proverbial, "What's that" or "I don't want any."

Left over fruit, fruit juices, cookies or a sandwich was given to the twenty-six children who received cod liver oil daily.

We were very grateful to Mr. Page for purchasing and loaning to the lunch program a refrigerator for our milk supply that was delivered every other day.

## STATE OF NEW HAMPSHIRE

### TOWN WARRANT

To the inhabitants of the Town of Fitzwilliam, in the County of Cheshire, in said state, qualified to vote in town affairs:

You are hereby notified to meet at the town hall in said Fitzwilliam on Tuesday, the 11th day of March next, at nine o'clock in the forenoon, to act upon the following subjects:

Art. 1. To bring in your votes for the election of Delegates-at-large; Alternate Delegates-at-large; District Delegates; Alternate District Delegates, to the national conventions of the Republican and Democratic parties to be held for the purpose of nominating candidates for President and Vice-President of the United States.

Art. 2. To bring in your votes for the election of one selectmen, town treasurer, town clerk, highway agent, one cemetery commissioner, one trustee of trust funds, three trustees of the library, three fire wards, three commissioners of Plante Memorial Park, town hall agent, sexton and superintendent of cemeteries, constable and prosecuting agent.

Polls will be open not later than 10 o'clock a. m. and close not earlier than 6 p. m.

Art. 3. To hear and act upon the reports of agents, committees and officers heretofore chosen.

Art. 4. To allow accounts against the town.

Art. 5. To see if the town will vote to raise and appropriate the sum of \$12,050 for town charges.

Art. 6. To see if the town will vote to authorize the selectmen to borrow money in anticipation of taxes.

Art. 8. To see if the town will vote to raise and appropriate the sum of \$5,000 for oiling town roads.

Art. 9. To see if the town will vote to raise and appropriate the sum of \$12,000 for town road maintenance and improvement.

Art. 10. To see if the town will vote to accept state aid for T. R. A. construction and appropriate the sum of \$779.85 for this purpose, the state to give \$5,199.

Art. 11. To see if the town will vote to raise and appropriate the sum of \$2,200 to help maintain a district nurse for the current year, the same to be expended under the direction of the Fitzwilliam District Nursing Association.

Art. 12. To see if the town will vote to raise and appropriate the sum of \$900 for the general care and maintenance of the town cemeteries, to be expended under the direction of the Cemetery Commission.

Art. 13. To see if the town will vote to raise and appropriate the sum of \$1,100 for the care and maintenance of the town library.

Art. 14. To see if the town will vote to raise and appropriate the sum of \$200 for the care of the common and sidewalks.

Art. 15. To see if the town will vote to raise and appropriate the sum of \$100 for the general care and maintenance of the Plante Memorial Park, the same to be expended under the direction of the Park Commission.

Art. 16. To see if the town will vote to raise and appropriate the sum of \$133, (1/100th of 1% of the valuation of the town), to the Monadnock Region Association of Southern New Hampshire for issuance and distribution of printed matter, newspaper and magazine advertising, and by other means calling attention to the resources and

natural advantages of the town, in cooperation with the other thirty-seven towns of the Monadnock Region.

Art. 17. To see if the town will vote to raise and appropriate the sum of \$250 to be used for the observance of Memorial Day, the same to be expended under the direction of the patriotic bodies.

Art. 18. To see if the town will vote to raise and appropriate the sum of \$125 for spraying the trees on the common, Plante Memorial Park, the cemeteries and streets.

Art. 19. To see if the town will vote to petition the State Tax Commission to have an audit of the town accounts made by the Division of Municipal Accounting, and raise and appropriate the sum of \$100 therefor.

Art. 20. To see if the town will vote to raise and appropriate the sum of \$400 to be paid to the Elliot Community Hospital of Keene, N. H., as determined by the number of day's hospital treatment furnished to residents of Fitzwilliam during 1951.

Art. 21. To see if the town will vote to raise and appropriate the sum of \$400 for the control of white pine blister rust, in cooperation with the State Forestry and Recreation Department.

Art. 22. To see if the town will vote to allow the Garden Club to move the old stone watering trough now located on the Upper Troy Road to the north end of the common inside the fence, and replace it with the stone watering trough now on the side of the road adjacent to land of Henry Bemis on the depot road. All expenses to be paid by the Garden Club.

Art. 23. To see if the town will vote to make the office of superintendent and sexton an appointed one, and give the cemetery commission authority to appoint said superintendent and sexton, each year, for a one year term of office.

Art. 24. To see if the town will vote to authorize the selectmen to set up a special fund from money received from the sale of cemetery lots in Pine Grove Cemetery, the fund to be drawn only by the cemetery commission, for improvement work or material used in connection with the improvement work in Pine Grove cemetery.

Art. 25. To see if the town will vote to authorize the installation of one street light on the pole in front of the Dr. George S. Emerson school, and raise and appropriate \$23.50 for the cost of one year's service.

Art. 26. To see if the town will vote to authorize the installation of one 6000 Lumen light at Fitzwilliam Depot on the corner of Route 119 leading to Richmond and the Village and raise and appropriate \$55 for the cost of one year's service.

Art. 27. To see if the town will vote to install a street light at the corner of Route 119 and the Richmond road near the residence of Frank J. VanArsdale, and raise and appropriate the sum of \$23.50 to pay for one year's service.

Art. 28. To see if the town will vote to raise and appropriate the sum of \$100 to make and erect a wood tablet on the front of the town hall bearing the following inscription:

THE THIRD MEETING HOUSE  
OF THE TOWN OF FITZWILLIAM

\*\* 1817 \*\*

It stands on the site of the second meeting house, which was built in 1816 and destroyed by fire nine weeks after it was consecrated.

\* \* \* \*

Acquired by the town of Fitzwilliam for  
use as a Town Hall.

Art. 29. To see if the town will vote to discontinue, subject to gates and bars, the road leading from the Turner farm north to the Appalachian road.



Art. 30 To see if the town will vote to discontinue, subject to gates and bars, that part of old Route 12, for which the new highway has been substituted, and lying easterly of the road between stations 359-50 and station 382-50 as shown on the maps of the Fitzwilliam Federal Aid Project F-141 (2), F-203 (8) and F-193 (2).

Art. 31. Whereas the State Highway Department has agreed to seed and set shrubbery and erect signs calling attention to the town of Fitzwilliam in the triangles at the north and south end of the new cut-off, provided the town will mow and care for the plots; now therefore to see if the town will vote to accept the above offer, the cost to be a charge against highway funds.

Art. 32. To see if the town will vote to authorize William F. Perry of Keene, N. H., in cooperation with the Fitzwilliam Town Library Association and the Library Trustees, without any expense to the town, to build and construct a fireproof addition to the Town Library in accordance with plans and specifications submitted at this town meeting, said addition to be the property of the town with its full custody and management vested in the Library Trustees, or take any other action thereto.

Art. 33. To see if the town will vote to authorize the Fitzwilliam town Library Trustees to remove, without expense to the town, the barn and so much of the ell of the present library building as is necessary to permit the construction of the fireproof addition to be given by Mr. William F. Perry, or take any other action thereto.
